AGENDA ITEMS

1. **Approval of minutes from the last meeting, 10/5/20** A motion was made to approve the minutes, as written, by Mallory Poole and was seconded by Sarah Chatterton. Unanimously approved by the council members present.

2. **Discuss current plan for Land Trust money allocations and address monies not spent last year due to the Soft Closure of Schools**

The council discussed the carry over funds due to the soft closure last year. We discussed using the funds for extra FOSS kits and adding additional time to the Reading Aide budget.

3. **Share money totals already spent this school year under the current Land Trust plan** (*this is combined with the plan created for TSSA monies and is called the Student Success Plan*)

- In the equipment category, we have a remaining balance of \$3,852.53.
- In the software category, we have a remaining balance of \$6,705.00.
- In the professional and technical services category, we have a remaining balance of \$510.

4. **Propose and discuss amendments to adjust spending allocations in current Land Trust Plan**

- **Proposed Amendment to Land Trust Plan:** Due to the Soft Closure of schools in the spring of 2020, Viewmont Elementary was unable to spend all of the funds as allocated in the 2019-2020 Land Trust Plan. Viewmont Elementary's School Community Council would like to amend Goal # 2 by spending an additional \$17,000 for the purchase of 2 additional FOSS Kits for Grades 4 and 5, an additional kit for grade 6, and one initial kit for grades K-3.

- **Proposed Amendment to Land Trust Plan:**

Due to the Soft Closure of schools in the spring of 2020, Viewmont Elementary was unable to spend all of the funds as allocated in the 2019-2020 Land Trust Plan. Viewmont Elementary's School Community Council would like to Amend Goal #1 by adding an additional \$3,000 to the Professional Salaries and Benefits expenditures in order to extend the reading paraprofessionals' schedules so that more students may be served in an intervention capacity.

5. Review Digital Citizenship and Safe Technology Report

- The Digital Citizenship and Safe Technology Report is posted on our school's website. It addresses both the District's plan and Viewmont's plans. A brief overview was provided to the council members.

6. Other (appointment of a potential additional parent member)

- Todd Morlock has expressed interest in serving on the council. He has a 2nd grader and a kindergartner at Viewmont this year. He would fill the open position.
- A motion was made to appoint Todd Morlock as a new parent member to the Viewmont's SCC. This motion was made by Mallory Poole and seconded by Vangee Watts. The motion passed with a unanimous vote of the council members present.
