# **AGENDA ITEMS**

- 3. Discuss proposed Land Trust Amendments.
- **Proposed Amendment (#1) to Land Trust Plan:** Due to the Soft Closure of schools in the spring of 2020, Viewmont Elementary was unable to spend all of the funds as allocated in the 2019-2020 Land Trust Plan. Viewmont Elementary's School Community Council would like to amend Goal # 2 by spending an additional \$17,000 for the purchase of 2 additional FOSS Kits for Grades 4 and 5, an additional kit for grade 6, and one initial kit for grades K-3.

# • Proposed Amendment (#2) to Land Trust Plan:

Due to the Soft Closure of schools in the spring of 2020, Viewmont Elementary was unable to spend all of the funds as allocated in the 2019-2020 Land Trust Plan. Viewmont Elementary's School Community Council would like to Amend Goal #1 by adding an additional \$3,000 to the Professional Salaries and Benefits expenditures in order to extend the reading paraprofessionals' schedules so that more students may be served in an intervention capacity.

4. Vote on Proposed Land Trust Amendments.

A motion to approve the proposed Amendment #1 was made by Vangee Watts and was seconded by Mallory Poole. The vote was unanimous.

A motion to approve the proposed Amendment #2 was made by Jadee Talbot and was seconded by Nichole Archer. The vote was unanimous.

# 5. Principal King shared BOY DIBELS Data with SCC.
